Our office investigates approximately 3,000-3,500 cases per year (pathology cases will not exceed case requirements designated by NAME), and is professionally and efficiently administered by Coroner Dotti Owens. We have a highly trained, well-staffed forensic division of Forensic Pathologists (2.5), Forensic Supervisor (1) and Forensic technicians (3), a 24 hour investigative force of ABMDI registered Medicolegal Investigators (13), Anthropologist (1), and a superb Administrative Staff (5).

The Coroner's Office is fully NAME and IACME accredited. We are a regional center providing consulting and pathology services to 31 Idaho counties and 1 sovereign nation. Moving forward there will be growth in our office, new technologies and state of the art facility enhancements. This provides a unique opportunity for individuals to help create an environment of progress, modernity and research while maintaining the absolute highest standards of medical legal death investigation to the people of Ada County, and remaining an active partner in the community in which they serve.

The ideal candidate must be certified by the American Board of Pathology in Anatomic Pathology, board eligible (certification required within 2 years) in Forensic Pathology, and eligible for medical licensure in the State of Idaho. In addition, the candidate must be skilled in performing autopsies and examining human bodies, providing expert testimony, and advising the Prosecutor's office in criminal proceedings relating to deaths.
