## **Immediate Opening: Deputy Chief Medical Investigator**

**Pay Range:** \$39.84-\$59.76 an hour

Johnson County Government is seeking a qualified candidate to fill the Deputy Chief Medical Investigator position. This is a new position, in the recently created Medical Examiner's Office (Est. 2020). The building boasts state-of-the-art equipment, including a CT scanner and Lodox. In-house toxicology will also be offered in the 33,000 square foot location. The current investigative caseload is about 2,775 cases per year and 632 scene responses per year. The Johnson County Board of Commissioners approved 6 new full-time positions in 11/2022 for 5 Medicolegal Death Investigators and a Deputy Chief Medical Investigator. These new positions will join the 5 current investigator positions within our office.

Johnson County, with a population of almost 600,000, is located in northeast Kansas and close to metropolitan Kansas City, Missouri – home to the 2020 Super Bowl champions, the Chiefs and the 2015 World Series winners, the Royals. In 2018, USA Today named Johnson County one of the top twenty best counties in the nation. Johnson County consistently ranks #1 in the "County Health Rankings" and is home to award winning parks (including several dog parks) and libraries. Johnson County has six excellent school districts and several colleges. Museums, shopping malls and the Kansas City International Airport are all nearby.

## Job Requirements

- A Bachelor's degree with major coursework in criminal justice, forensics, crime scene investigation, anthropology, medicolegal death investigation, law enforcement, biology, anatomy, pharmacology, nursing, funeral sciences, or relevant studies
  - Master's degree in Criminal Justice, Biological Science, Forensic Science, Natural science, Anthropology, Nursing, or any other medically relevant field is preferred.
- Eight (8) years of experience of forensic medical investigative practices and techniques including proper handling and processing of evidentiary material and knowledge of medical terminology, anatomy and physiology and working with human remains required.
- Three (3) years leading, directing, supervising, or coordinating the work of others is required.
- **Registry certification (BASIC) with the American Board of Medicolegal Investigators (ABMDI).** The candidate will need to obtain the Board Certification (ADVANCED) within 6 months of employment. Registration and Testing would be paid for by Johnson County.
- And a valid driver's license with an acceptable driving record is also required.

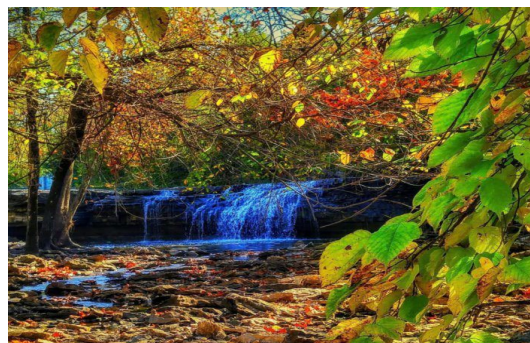
